### Use of Funds

- <u>Utilization of Funds Form</u> LEA grantees must complete and submit the Funds Utilization Form for planned items in bulk or large purchases.
- Items might include:
  - bulk technology purchase (i.e. cell phones, mobile hotspots, wireless service plans),
  - a bulk supplies purchase to support school attendance (i.e. personal care items, school supplies, store cards/prepaid debit cards)
  - planned contracted services with community-based organizations (i.e. mental health, counseling or tutoring services).

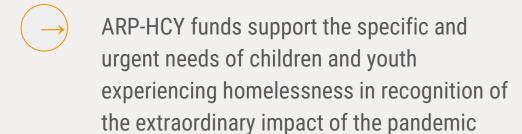

**Overview** 

### **ARP-HCY Overview**



- Specific and urgent needs include academic, social, emotional, and mental health
- Funds support identification, enrollment, and school participating, including through wraparound services

## ARP-HCY Funds

- Supplemental to other funding sources (Title I-A, ESSER, state and local funds, etc)
- 2 Expenses, including for support services, must be educationally related
- SEAs and LEAs are encouraged to conduct a needs assessment to determine how to best utilize funds to support students experiencing homelessness

Use of Funds

# Use of ARP-HCY Funds (1)





Any expenses that are reasonable and necessary to facilitate the identification, enrollment, retention, and educational success of children and youth experiencing homelessness



Any purposes permitted by the EHCY program



Connect students and families to enrichment programs



Provide wraparound services (academic supports, trauma-informed care, social-emotional support, and mental health services)



Purchase needed supplies (e.g., PPE, eyeglasses, school supplies, personal care items)

# Use of ARP-HCY Funds (2)

**US Department of Education Guidance** 



Provide transportation to enable children and youth to attend classes and participate fully in school activities



Purchase cell phones or other technological devices to enable students to attend and fully participate in school activities



Pay for short-term, temporary housing (e.g., a few days in a motel) when the only reasonable option for COVID-safe temporary housing and necessary to enable students to attend school and participate fully in school activities



Provide store cards/prepaid debit cards to purchase materials necessary for students to participate in school activities



Increase liaison and McKinney-Vento program capacity

# Use of Funds Examples

## Increase Outreach and Identification

- Increase staff hours of the homeless liaison or other staff support students experiencing homelessness
- Run an outreach campaign in the community to increase awareness of McKinney-Vento
- Improve or enhance enrollment materials update enrollment forms with screening questions, develop district materials
- Enhance and improve training for all teachers and staff to assist with identification; provide training to community partners to assist with identification

# Use of Funds Examples

## Communication/ Wrap-Around Supports

- Provide prepaid cell phones or other technological devices to enable students to attend and fully participate in school activities
- Partner with community-based organizations or hire systems navigators to help families and youth access wrap-around services
- Assist students and families with basic needs like health care, hygiene supplies, accessing food pantries, etc.
- Provide store cards/prepaid debit cards to purchase materials necessary for students to participate in school activities
- Pay for short-term, temporary housing (e.g., a few days in a motel) when the only reasonable option for COVID-safe temporary housing and necessary to enable students to attend school and participate fully in school activities
- Provide systems navigators to partner with eviction courts and housing agencies/programs

# Use of Funds Examples

### **Mental Health**

- Implement and train staff on traumainformed practices
- Provide mental health services to students, as needed for participation and engagement in school
- Increase school counseling capacity to specifically support students' socialemotional needs, school engagement, and postsecondary planning
- Hire FAFSA mentors or graduation coaches

# Use of Funds Examples

## Academic Support

- Provide transportation for students to participate in extracurricular activities and enrichment opportunities
- Provide tutoring both in-person and virtually
- Provide summer tutors or staff time to support academic engagement

# Use of Funds Examples

## **Transportation**

Provide transportation to enable children and youth to attend classes and participate fully in school activities:

- Purchase a vehicle and pay a driver to provide transportation
- Hire a transportation coordinator to ensure bus routes and other transportation is arranged quickly and efficiently
- Develop partnerships with public transportation
- Pay for driver's education and assist with obtaining driver's licenses, as needed for school of origin transportation

# Use of Funds Examples

**Early Childhood** 

- Improve and enhance transportation options for young children to access educational opportunities
- Hire early childhood specialists to support identification and services

# Use of Funds Examples

# Community Partnerships

- Both SEAs and LEAs are encouraged to "award contracts to community-based organizations that are well-positioned to identify children and youth experiencing homelessness in historically underserved populations such as:
  - rural children and youth,
  - Tribal children and youth,
  - students of color,
  - children and youth with disabilities,
  - English learners,
  - LGBTQ+ youth, and
  - pregnant, parenting, or caregiving students, and
- connect them to educationally-related support and wraparound services"

## Key Takeaways

## Strategic Use of Funds

- 1 ARP HCY <u>should not</u> replace funds that are otherwise available (ESSER, Title I, other out of school programs).
- Make sure there is a plan to spend down funds before the deadline!
- 3 Start planning now for sustainability!

- Liaisons are encouraged to collaborate with other LEA staff in planning uses of funds

# **Considerations for Planning**

To Be Reviewed Quarterly



Is it necessary to submit a budget revision or amendment to the SEA for approval of these activities? If so, what is the SEA approval process timeline?



Is there an LEA process for approval of activities, and if so, how long does that take?



Do other stakeholders need to be involved in the planning process?



Can other community-based organizations or regional service providers be contracted to provide this support?



What data can be collected on the activities to help demonstrate effectiveness and make the case for sustainability?

# Additional Quarterly Considerations

- Identify uses of ARP-HCY funds to meet the most urgent needs
- Identify other funds that may be needed to initiate/supplement
- Set up time to meet with business office staff, if needed
- Get on school board agenda, if needed
- Do you need technical or program assistance? Reach out to your statewide contacts for support and guidance
- Plan additional action steps

- Facilitate sustainability conversations

### Final Spend Down of Funds Balance

- Ensure all funds are spent by deadline
- Wrap up final activities

### **ARP-HCY II Implementation Survey**

- Part of Pennsylvania's State Plan for implementing ARP-HCY II
- Designed to gather consistent information across LEAs based on the ARP-HCY II guidance about services students experiencing homelessness receive
- Expected to be repeated annually at the end of each school year and follow LEA implementation over time
- Guides technical assistance and support by the state/regional ARP-HCY II teams



### ARP-HCY II Implementation Survey Summer 2022 & School Year 2022-23

- The homeless liaison will receive the blast email from <a href="mailto:ECYEHSupport@aiu3.net">ECYEHSupport@aiu3.net</a>.
- Directions for accessing/completing the survey will be included in the email.
- The implementation survey should take about 10 minutes to complete. It is highly recommended that liaisons print the survey to assist in gathering all necessary information before attempting to complete it online.
- Each school district, charter school, career and technical center, or intermediate unit will submit only ONE survey.
- The implementation survey will need to be completed by any LEA receiving ARP-HCY II funds no later than May 12, 2023.

### **ECYEH System Service Delivery**

- Service Delivery (adjusted/expanded for 2022-23)
  - Title I
  - ESSER (new)
  - MV Funds
  - ARP-HCY Funds (LEA vs. Regional)
  - Other Funding
- Determine the type of service (e.g., Transportation) and mark appropriate funding source as "Yes"
- If a type of service has multiple funding sources, mark all appropriate sources as "Yes"
